2. Community Financial Allocations

Tyler Thompson, Manager of External Financial Services, introduced himself, and provided an overview of the proposed funding model for currently-available Provincial funds for Community support. Along with John Bieker, Chief Governance Officer, and Celina Moore, Director of Community Services and Sport, noted that:

- Three models were presented to the Board;
- There is no need for MNGA approval or to take the proposal to an AGM;
- Changes can be made in the future, however right now the important thing is to get the funding to Communities.

In response to questions, Mr. Thompson provided the following information:

- Calculations are very much based on numbers;
- Ratios that determine funding can be changed;
- Spending deadline is the end of this fiscal year.

In discussion, members noted:

- This is the first time the Province has provided any Community funding and even though it is far below what is needed, it is a starting point;
- Going forward the scale can be made tighter; and,
- It will be important to get the Regional Governance Councils onside.

Following discussion, the Committee consented to approval of the proposed funding model and requested that staff bring the model to RGCs for input and possible changes in the future.

3. June 2023 MNGA Discussion - Review of Resolutions

Discussion ensued regarding Resolution 9 for the June 2023 MNGA, regarding expanding citizenship to people who can demonstrate family/historical ties to BC but are not residents of the province. Members noted that other Métis governments have opened up citizenship to Métis living out-of-province.

Nicole Ludwig, Manager of Governance, and Mr. Bieker provided additional information regarding existing citizenship practices for people who live temporarily out of province (e.g. - Military or RCMP assignment, or students attending school), and the potential impacts on adults whose parents are MNBC citizens but have no Nation in their province of residence to join.
