<p>In addition to her role as a member of the MNBC Board of Directors:</p> <ul style="list-style-type: none"> ● Is the Minister of Women and Gender Equity ● Liaises with Ministry of Women and Gender Equity leadership staff to address issues of mutual concern. ● May be appointed to other Ministries. ● Chair of MWBC Council ● Responsible for carrying out the wishes of the MWBC Provincial Governance Council; ● Issues proper Notice of Meetings and Agenda preparation for the MWBC at least 4 times per year. ● Ensures MWBC Council meetings are a safe, respectful, and inclusive space for MWBC Council members, staff and any other guests ● Attends all meetings of the MWBC Provincial Council, Métis Nation Governing Assembly, and the MNBC Annual General Meeting. ● Represents MWBC at affiliated Métis Women’s meetings and events or appoints an alternate representative to attend. 	<p>In addition to their role as a member of the MNBC Board of Directors:</p> <ul style="list-style-type: none"> ● Is the Minister of Youth. ● May be appointed to other Ministries. ● Represents MYBC at affiliated Métis Youth meetings and events, or appoints an alternate representative to attend; ● Supports and ensures the effective governance of the MYBC Council by preparing meeting agendas, following up on action items and keeping MYBC Council accountable and aligned with MYBC Strategic Plan ● Ensures MYBC Council meetings are a safe, respectful, and inclusive space for MYBC Council members, staff, and any other guests ● Attend all meetings of the MYBC Provincial Governance Council, Métis Nation General Assembly, and the MNBC Annual General Meeting ● Communicate the voice of all Métis youth and advocate on their behalf by bringing observations, concerns, and findings to MYBC Council meetings ● Provide a Métis youth perspective to MNBC initiatives as required ● Attend monthly check-in meetings with the Ministry of Youth leadership staff 	<p>In addition to their role as a member of the MNBC Board of Directors:</p> <ul style="list-style-type: none"> ● Is the Minister Responsible for Métis 2SLGBTQQIA+ people on the MNBC Board of Directors and may be assigned to other Ministries. ● Represents 2SLGBTQQIA+ at affiliated Métis 2SLGBTQQIA+ meetings, events, or appoints an alternate representative to attend. ● Collaborates with MNBC staff to ensure the effective governance of the 2SLGBTQQIA+ Council, which includes but not limited to, preparing meeting agendas, tracking action items, and keeping 2SLGBTQQIA+ Council accountable. ● Chairs 2SLGBTQQIA+ Council meetings, and ensure that meetings and safe, respectful, and an inclusive place for all members of Council, staff, and guests. ● Attends all meetings of the 2SLGBTQQIA+ Council, MNBC Board of Directors, Métis Nation General Assembly, and the MNBC Annual General Meeting. ● Supports the recruitment of regional representatives. ● Participates in Strategic Planning, when required. ● Liaises with appropriate MNBC staff, as needed.
