Unfinished Business - Citizenship Act Amendments: Adoption Clause	Citizenship Act	People adopted as children will no longer be able to acquire Métis citizenship through their Métis Adoptive Parent(s). The goal is to ensure that the MNBC Registry is reflective of the Métis population in British Columbia.	This resolution was withdrawn by unanimous consent of the MNGA.
2025-2026 MNGA Meetings	N/A	The MNGA is requested to approve the meeting schedule (as set out in the MNGA Act) and the whether the meeting will be held in-person or virtually. These dates will also impact your RGC dates, as those occur around the MNGA schedule. Constitutional Updates for Clarity of Equality Rights	Constitution	The section in the Constitution pertaining to the fundamental rights of Citizens would be updated with the BC Human Rights Code's definitions pertaining to discrimination. The change would update the legislation from 4 categories of discrimination to the 12 recognized classes. Enhancing MVBC Representation at the MNGA and Clarifying the Relationship with MNBC Board of Directors	Constitution; MNGA Act; Veterans Act.	The Chair of the Métis Veterans BC (MVBC) would be able to attend, submit resolutions on behalf of MVBC and its Committee, and participate in discussion pertaining to Veterans issues at the MNGA. The Chair, however, would be non-voting—meaning they can submit items and discuss, but they would not be able to vote. The MVBC Chairperson would also liaise with the MNBC Board of Directors, and attend in-person MNBC Board meetings at least twice yearly to report on MVBC activities and needs. The MVBC will maintain its relationships with Provincial and Federal bodies ensuring continues service for its members.	This resolution was approved and will be added to the 2025 AGM Agenda for adoption.
Amendments to the Veterans Act	Veterans Act	Further definitions would be added to the Act to provide more clarity. The class of "Associate Members" would be removed. Further bounds and responsibilities are added for the MVBC Executive Committee. Election cycle would be aligned with the MNBC elections.	This resolution was approved with an amendment to add a 2SLGBTQQIA+ Representative to the MVBC Committee, in consultation with the 2SLGBTQQIA+ Provincial Governance Council.  The resolution as approved will be added to the 2025 AGM Agenda for adoption.
Support of Governance Succession Planning	N/A	The MNGA requests that the Board of Directors consider approving funding allow for 2 members of each Chartered Community to attend the in-person MNGA and related events (e.g., RGCs) to train Community Board members on the governance-related elements.	This resolution was approved and will be added to an upcoming MNBC Board of Directors meeting agenda to ascertain feasibility.

Honorarium for Community Representatives at MNBC Meetings	N/A	The MNGA requests the Board of Directors to consider providing daily honoraria for Community members attending in-person MNGAs, AGMs, and RGCs in recognition of representatives' service to MNBC.	This resolution was defeated.
Role of President and Vice- President in Citizen Representation	N/A	This will affirm the MNGA's opinion that Community Board members could reach out to the MNBC President or Vice President if the Regional Directors does not have the ability or is unwilling to address the issue if the Community member has a contentious relationship with the Director, and <i>IF</i> the President or VP is <i>willing</i> to step in. Technically, MNBC legislation is silent on this matter at this time. This would be a non-legislative decision made by the MNGA, but would inform general practices.	This resolution was defeated.
Reinstatement of MNBC Citizenship for Individuals Previously Removed for Not Meeting Métis Homeland Criteria under the Citizenship Act	N/A	If approved, this will ask MNBC to provide MNBC Citizenship to individuals who were not approved or had their Citizenship removed under Article 6 of the Citizenship Act, provided if Citizenship was denied/removed because they are linked to one of the seven Ontario communities identified in the MNC report.	This resolution was withdrawn by the submitter.
