2. Conflict of Interest

Mr. Bieker reviewed the changes to the proposed resolution noting that if approved, the resolution will clarify how a conflict of interest can be determined, and that the proposed Article 3.6 provides more guidance on organizations that can be considered as aligned with MNBC.



In discussion, members suggested changes to the proposed motion, and noted:

- There are two pieces to the resolution: one for individual members to declare conflict for themselves and the other for the Assembly to determine a conflict of interest, and this should be explained at the MNGA.
- That the restrictions on membership in other Métis governments or organizations is limited to decision-makers of those organizations as it can be very difficult for people to be removed from membership rolls.
