Support funding for in-person mental health counselling, including opening a Métis-informed Drug and Alcohol treatment centre

Advocate for Region 5 Métis Housing developments to be a high priority, focusing on new builds, offering below market rental rates with built in maintenance fees, rent-to-own initiatives, and reserving unit for post secondary students (including mature students with families).

Increased funding for Métis Children & Family Agencies, Métis Child Care Builds, & programs that support Métis families

## Respectful Partnerships

Ensure any major infrastructure purchases that impact the environment or relationships with First Nations (such as pipelines) are decided by referendum using mail-in ballots

Engage MNBC citizens when it comes to any decisions regarding the MNC expert panel's research into the 7 MNO "newly recognized communities"

## Section 35 Rights Recognition

Educate Métis citizens and partners about non-site specific Section 35 rights, including Education, Self Determination, Health, Justice, Housing, and more.

Fast track the implementation of the 231 calls for justice regarding Missing and Murdered Indigenous Women and Girls

Jurisdiction over Children and Youth in Care and enhance supports available to family to ensure families stay intact
