
Reaching Home Program Application Form

The Reaching Home Program supports low-income Métis Citizens who are homeless, precariously housed or facing housing instability by providing housing loss prevention and housing stabilization services.

Program services include, but are not limited to:

- **housing crisis interventions** and eviction prevention support;
- **assistance with rent and utility arrears;**
- **support with housing searches** and the rental application process;
- **assistance and support for those exiting homelessness**, including damage deposit and first months' rent;
- **assistance with transportation costs** to access emergency accommodations;
- **information on community resources** and supports; and
- **information and referrals to other relevant MNBC Programs** and resources.

The applicant must:

- **be experiencing homelessness** or at imminent risk of becoming homeless or having a utility service disconnected;
- **be a Citizen** of MNBC;
- **be a resident of BC** and provide one piece of Government of BC issued photo identification (BCID, Driver's License, etc.) to verify;
- **have a total gross annual household income of \$54,000** or less;
- **not have assets of more than \$2,500** – includes balance of chequing/savings accounts, TFSA, RRSP, as well as physical assets (excluding a personal vehicle); and,
- **not be receiving financial support from another Ministry of Housing program** or wrap around support from STEPS for shelter.

- The applicant declares that all the information given in this application form is true and complete.
- The applicant declares that the annual income declared is factual and true.
- The Métis Citizen applicant(s) declares that they have not applied for First Nation status under Bill C31, Bill C-3 or Bill S-3 or any other government legislation. The MNBC Central Registry Office will periodically verify that grant recipients maintain MNBC Citizenship.
- The applicant acknowledges and agrees that the facts given in this application form will be kept and disposed of as required by the [**Information Management Act**](#).
- The applicant agrees that MNBC may collect data and contact them from time to time for the purpose of conducting any client-related surveys.
- The applicant(s) understands that this application does not obligate MNBC to approve funding.
- All applicants who give personal information to MNBC shall be required to consent to the release of that information to MNBC to comply with the BC [**Personal Information Protection Act**](#) (PIPA) and [**Freedom of Information and Protection of Privacy Act \(FIPPA\)**](#).
